- Identifying hazards in the work place, assessing the risks related to them and implementing appropriate preventive and protective measures,
- Monitoring and reviewing risk controls to ensure they remain effective,
- Establishing and enforcing safe methods of work,
- Involving our employees and contractors in the decision making processes through structured communication, consultation and training,
- Providing ongoing educating and learning for our employees to comply company's HSE policy to enable them to work in the safest ways possible,
- Carrying out regular internal assessments and report annually on performance.

Commitment

The management of Alpha Power Engineering is committed to improving every aspect of health and safety by involving all staff and sub-contractors in reducing or eliminating any risks and hazards in the workplace and providing sufficient resources to comply with the Health, Safety and Environment guidelines. Managers have an unquestionable commitment and responsibility to safe working situations for employees, and associated individuals in the workplace.

Responsibilities

- The overall responsibility for the promotion of Health and Safety of employees at work is vested in the Senior Management of Alpha Power Engineering Co., Ltd.
- The managers in Alpha Power Engineering are directly responsible through normal management structure for health, safety and environment matters in the business operations under their control.
- They reinforce contractors to utilize and respect all the safety devices and protective equipment provided to ensure the safety of personnel while working with Alpha Power Engineering.
- They review work practices and policy to ensure a continuous improvement and awareness of health and safety issues at working sites.
- To minimize incidents at work by reporting, investigating and analyzing any near miss accidents to ensure that incidents do not recur.

- All employees must comply all safety procedures and controls as dictated by Alpha Power Engineering when at work.
- They have a responsibility to take reasonable care of themselves and others while at work and to participate positively in the task of preserving workplace health, safety and sound environment.
- The Management oversees the company's health, safety and environment activities and reports on these matters to the Board of Directors.
